Advice Letter No. 80-W is in compliance with the Ordering Paragraph in Resolution (Res.) M-4839. LUKINS seeks to revise its current Reimbursement Account User Fees (RAUF) from 1.40% to 1.23% effective April 1, 2019. The RAUF is added to each customer's bill.

3. The analysis, calculations, or data in the advice letter contain material error or omissions;
4. The relief requested in the advice letter is pending before the Commission in a formal proceeding; or
5. The relief requested in the advice letter requires consideration in a formal hearing, or is otherwise inappropriate for the advice letter process; or
6. The relief requested in the advice letter is unjust, unreasonable, or discriminatory (provided that such a protest may not be made where it would require relitigating a Prior order of the Commission). A protest shall provide citations or proofs where available to allow staff to properly consider the protest. A response or protest must be made in writing or by electronic mail and must be received by DWA within 20 days of the date this advice letter is filed. A **1.23%** surcharge shall be added to all customer bills. **(R)**

The surcharge to recover the cost of that fee is ordered by the Commission under authority granted by the PU Code Section 433.
